Protecting the Olympic Properties

FINANCING THE OLYMPIC GAMES

The IOC and the organizations that make up the Olympic Movement are entirely privately funded. Support from the business community is crucial to the holding of the Olympic Games, one of the most effective international marketing platforms in the world, reaching billions of people in more than 200 countries and territories across the globe. The IOC distributes more than 90 percent of its revenues to



organizations throughout the Olympic Movement to support the staging of the Olympic Games and to promote the development of sport worldwide.

Broadcasting the Olympic Games is the most important means of communicating the Olympic ideals worldwide. The Primary broadcasting objective is to ensure that the widest possible audience has an opportunity to experience the Olympic Games. As the owner of the global rights for the Olympic Games- including broadcasts on television, radio, mobile and internet platforms- the IOC grants its partners exclusive broadcasting rights in their respective territories.

The IOC's worldwide sponsorship program, the Olympic Partner (TOP) Programme, was established to enable long-term corporate partnerships of benefit to the Olympic Movement. The TOP Programme provides each worldwide partner with exclusive global marketing rights and opportunities within a designated product or service category.

Consequently, the IOC must be able to protect the exclusivity granted to its broadcast and marketing partners and needs to have the necessary means to prevent third parties from making any unauthorized association with the Olympic Games.

PROTECTING THE OLYMPIC PROPERTIES

Numerous countries have adopted permanent national legislation protecting the Olympic properties. Although the Olympic Movement's efforts have contributed to the implementation of legislation, the parliaments that have adopted such measures also understand the importance of sport and the Olympic Movement, as well as the need to protect the properties related to them.

Adopting specific legislation has also proved necessary in countries that host an edition of the Olympic Games. Such legislation not only concerns the protection of the Olympic properties, but also provides the means to fight against ambush marketing and to regulate advertising, in particular in and around Olympic venues. The first specific legislation related to an edition of the Olympic Games appeared in Canada prior to the Montreal 1976 Olympic Games. Since the Sydney 2000 Olympic Games, all host countries have adopted such legislation; this will also be the case for future editions of the Olympic Games, such as Pyeongchang 2018 and Tokyo 2020.

Do you know what to do In case of emergency

First

Assess the situation. Your first Priority is to see if there is any danger to you. To casualty and here bystanders.



Then

Make the surrounding area safe. The general rule you should avoid moving casualty unless there is a hazard that you cannot remove. If there is nothing hazard that you could do then remove that casualty from the scene as last resort.



Next Step

Emergency aid is the next step. Use the primary survey (Check A.B.C.) to quick carry out an initial assessment of the casualty.



Check Air way



Check Breathing



Treat severe bleeding

Enlist help from others if possible. Ask bystanders to call for emergency services.




Then Get Help

Get help from bystanders and others around you. (Ask them to call an ambulance or suitable vehicle)



Finally Aftermath

Aftermath is how you deal with situation. E.g. talking to ambulance, police and comforting those who were not injured by the accident. If possible remove whatever caused the incident to prevent further accident.

❖ SO LET'S GET TO KNOW THE L.P.G. WE USE EVERY DAY.

❖ WHAT ARE THESE L.P.G.???

Liquefied Petroleum Gasses (L.P.G.) are highly combustible and inflammable when comes in contact with the Source of any ignition in air. Millions of people in the world are utilizing this L.P.G. As The Most Convenient, economical and pollution free Cooking purposes.

L.P.G. a really convenient, super pressurized gas stored in liquid form in a tank, canister bottle.

The flash point of L.P.G. is -60 C° to -140 C° . This is the minimum temperature at which propane will burn on its own after ignition. So we know L.P.G. is very highly Flammable Gas.

L.P.G. Substance is called a rapidly expanding gas and heavier than air. So that we handling be carefully.

❖ Although dangerous, properly handled can be avoided.

❖ HOW TO SAFE HANDLING OF L.P.G.

01. Install the L.P.G. Cylinder vertically in uncovered, airy and visible distance below the cooking platform.
02. Cooking oven or any other ignition Sources should not be kept in close proximity the Gas Cylinder.
03. Prior to turning on the gas cylinder in the morning it should be ensured first that no sign of gas accumulation inside the room by complete opening of all doors and windows.
04. Regularly checking of the gas tube connections on both cylinder and oven ends will help to detect any defects in the gas tube to avoid chances of gas leakage and subsequent accidental hazards.



- 05. Using standard hose and hose clip and regulator.
- 06. Don't use any candle or match light to check any sing of gas leakage from the cylinder which may cause any fire hazards.
- 07. Instead applying solution of soap and water in value or pipe joints will be safe and effective to detect gas leaks.
- 08. Contact immediately the service department of the authorize L.P.G. Supplier to attent and rectify the faults.
